Are there services covered before you meet your <u>deductible</u>?	Yes. Services from Indian Health Care <u>Providers</u> , In-Network <u>Preventive Care</u> services, services with a <u>copayment</u> , and In-Network <u>hospice services</u> are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes.
