Are there services covered before you meet your deductible?	Yes. In-Network <u>Preventive Care</u> services, services with a <u>copayment</u> , some <u>prescription drugs</u> , and In-Network <u>hospice</u> are covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? **Yes.**
