Are there services covered before you meet your deductible?	Yes. Services from Indian Health Care Providers, In-Network <u>Preventive Care</u> services, services with a <u>copayment</u> , <u>prescription drugs</u> , and In-Network hospice are covered before you meet your <u>deductible</u> .
