What is the overall <u>deductible</u>?	In-Network: \$2,500 Individual / \$5,000 Family Out-of-Network: \$10,000 Individual / \$20,000 Family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. In-Network <u>Preventive Care</u> services, services with a <u>copayment</u> , <u>prescription drugs</u> , and In-Network hospice are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan provide Minimum Essential Coverage? Yes.
